## Auditor

## Treasurer

**Bruce Bagley '53** has acted as Treasurer of the alumni's books since 1995. To ensure the transparency of the organization, Bruce feels it is advisable that another person should assume this responsibility.

The Treasurer :

1. maintains an accurate, documented accounting of the Association's Membership and Scholarship Funds and provides monthly statements at executive meetings and for annual audit purposes;
  2. is responsible for paying the debts assumed by the Association and to issue cheques as instructed by the Executive;
  3. is responsible for completing the Association's income tax returns;
  4. is to wisely invest the Association's surplus money as instructed by the Executive.
